- 7. The computer generated date as authenticated by the Principal Registrar / Registrar (Judicial) of pre-admission matters, will be treated as Court given date and the matter will be listed on that date.
- 8. Only those Mention Memos may be entertained before DB-I which requires preponement of Computer Generated date.
- 9. No Mention Memos will be entertained in those cases, in which a fixed date has been given by a Judicial order.
- 10. All bail applications under section 438 & 439 Cr.P.C. arising from the same crime number of the same Police Station and applications/matters for suspension of sentence under section 389 / 397 Cr.P.C, Section 53 Juvenile Justice (Care and Protection of Children) Act 2000 / Sec. 102 of the Juvenile Justice (Care and Protection of Children) Act, 2015 and u/s 14A (2) of Scheduled Caste and Scheduled Tribes (Prevention of Atrocities) Act, 1989 as amended by the Amendment Act, 2015, arising from the same judgment / orders filed by the different applicants separately will be listed before the same Hon'ble Judge(s) or as directed by Hon'ble Acting Chief Justice.
