- 3. Learned Advocates / Parties-in-person / Registered Clerks may file cases / applications / documents, etc. in physical form at the Presentation Centre / Filing Counters. - 6. Learned Advocates / Parties-in-person are requested to submit Mention Memos only in those cases, which are of real urgency. All such Mention Memos shall be submitted by assigning brief, specific & pointed reasons, which highlight the urgency.
- 7. The computer generated date as authenticated by the Principal Registrar / Registrar (Judicial) of pre-admission matters, will be treated as Court given date and the matter will be listed on that date.
- 8. Only those Mention Memos may be entertained before DB-I which requires preponement of Computer Generated date.
- 9. No Mention Memos will be entertained in those cases, in which a fixed date has been given by a Judicial order.
