No. A-2877.—In exercise of the powers conferred by Articles 225 of the Constitution of India, Section 54 of the States Reorganisation Act, 1956, clauses 27 and 28 of the Letters Patent, the High Court of Madhya Pradesh, hereby, makes the following amendments in the High Court of Madhya Pradesh Rules, 2008, which shall come into force from the date of their publication in the Madhya Pradesh Official Gazette.

#### **AMENDMENTS**

### In thd said rule,-

- 1. In chapter I, in sub-rule (7) of Rule 4, between the words "pending" and "main case" the words "or disposed" shall be inserted.
- 2. In chapter I, in Rule 4, for sub-rule 12, the following sub-rule shall be substituted, namely:
  - "(12) "Part-heard case" means a case which is marked "part-heard" by the court."
- In chapter II, in Note (1) (b) of Rule 1, the words "including habeas corpus" shall be deleted.
- 4. In chapter II, after Note (1) (b) of Rule 1, the following note shall be added namely:
  - "(ba) A writ petition in the nature of habeas corpus shall be characterized by letters "H. C." within brackets, placed after the year of institution e.g. W. P. No. . . . . . . of 2022 (H. C.)."

- 5. In chapter II, in Rule 11, the words "/recall/modification/clarification" and the words "or an application for enlargement of time" shall be deleted.
- In chapter II, sub-rule (2) of Rule 12 shall be deleted.
- 7. In chapter II, after Rule 12, the following rule shall be added, namely:
  - "12 (A). Miscellaneous Second Appeal.—Any other appeal of civil nature, except appeal covered under Rule 12 of this Chapter, provided or permissible under any law, for the time being in force, against an appellate decree"
- 8. In chapter II, in Rule 16, for sub-rule (5), the following sub-rule shall substitued, namely:
  - "(5) An appeal under section 378 of The Code of Criminal Procedure Code 1973, which is accompained by an appplication seeking grant of leave to appeal under section 378(3) and (4) of The Code of Criminal Procedure 1973",
- 9. In chapter II, sub-rule (1) of Rule 21 shall be deleted.
- 10. In chapter II, after Rule 30, the following rule shall be added, namely:
  - "30A. An Application for recall/midification/clarification of an order/judgment or extension of time, supported by an affidavit and with documents, if any, shall be registered as an I. A. (Interlocutory application) in the main case."
- 11. In chapter IV, in sub-rule (1) (a) & (b) of Rule 13, between the words "Final" and "order", symbol and word"/Interlocutory" shall be inserted.
- 12. In chapter IV, in sub-rule (1) (a) & (b) of rule 13, between the words "review," and "clarification", the word and comma "recall," shall be inserted.
- 13. In chapter IV, proviso to sub-rule 1 (a) of Rule 13 shall be deleted.
- 14., In chapter X, in sub-rule (1) of Rule 6, between the words "pending" and "main case" the words "or disposed" shall be inserted.
- 15. In chapter X, in Rule 25, after the words "Central Government" the phrase "any local or other authority or any of their officers" and "of any such local or other authority or any of its officers" shall be deleted.
- 16. In Rule 16 of chapter XI, the words "one week" shall be substituted by the words "four months".
- In chapter XII, in Rule 2, between the words "service post card (S.P.C.)" and "issued as far as possible", the words "by Registered Post with Acknowledgment due" shall be inserted.
- 18. In chapter XII. Rule 18 shall be deleted

- 19. In chapter XIV, after Rule 26, the following rule shall be added. namely:
  - "26a. Every drafts of decrees, remand orders, writs and certificates of order shall be printed on good quality plain green sheet having A4 size with minimum 75 GSM and printed on single side of paper having font "Time New Roman" with size of 14 and with line spacing of one and half (1.5)."
- 20. In chater XVII, after Rule 1, the following rule shall be added, namely:
  - "1a. Every judgments and order or award shal be printed on good quality plain green sheet having A4 size with minimum 75 GSM and printing on single side of paper having font "Time New Roman" with size of 14 and with line spacing of one and half (1.5)."
