Please refer to your online application in form "A" Dated 12.01.2021 registered at Jabalpur at I.D. No. 36/2021 dated 12.01.2021 received on transfer in Form "C" vide D No. 060 Jabalpur Dated: 20.01.2021 from Shri Deepak Bansal, Registrar (J-1) and Public Information Officer, High Court of M.P., Jabalpur, received in this Bench Registry vide Inward No. 103 dated-29.01.2021 and registered at this Bench Registry at I.D. No. 02/2021-2022 dated 29.01.2021 addressed to the undersigned regarding supply of following information under Right to Information Act, 2005 as under:-

**"I had filed a petition number WP 28475 against BR Ambedkar University of Social Sciences and others on which the Honorable MP High Court Indore bench had ordered on 30.12.2019 that the respondents should be served notice and they should reply within two weeks. However, despite more than a year having elapsed the respondents have not filed any reply and neither has the case been listed since 03.04.2020 due to COVID. My rights as a student of the University are being seriously violated by this reluctance of the University to file a reply to the notice that has been served to it. When will the University file its reply and when will my case be listed for hearing so that I can get Justice."**

But the information desired by you cannot be supplied due to the following reasons:-

1. The information required by you is not under the purview of the "Information" defined u/s 2 (f) of the Right to Information Act, 2005. SPIO is not supposed to answer the query/question.
2. As no clear and specified particulars of the information (no clear number with year of the case) sought and details are not specified by you in the application as per Section 6 (1) (b) of the Right to Information Act, 2005.
3. Moreover, such information can not be supplied under the Act as it does not exist in the desired format as applied and the undersigned is not supposed to create the information as per desire of the applicant. The authority can neither re-shape nor cull the information.
4. The information sought under RTI Act 2005 is required to be very specific and precise, so that, the Authority may conveniently supply the information.

**As per Section 19 of the Right to Information Act, 2005, you may file an appeal to the Appellate Authority (Principal Registrar, High Court of M.P., Indore Bench) within 30 days of the issue of this order.**
