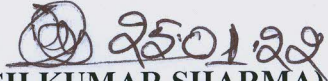
"1. Please provide me information about next tentative date computer generated in this case number WP/4640/2016 because this case has not been updated after 25.11.2021"

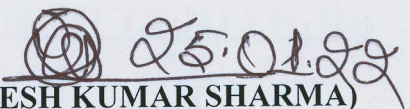
