In accordance with the provisions of Rule 7 (1) (A) (ii) of the said Rules 2006, a citizen/applicant is required to pay fee of Rs. 50/- in the form of Non-Judicial Stamp or Treasury Challan, pasted with self-attested photograph (in original) of the applicant on Form "A" and you have failed to paste/attest your photograph and instead of enclosing Indian Non Judicial Stamp of Rs. 50/- you have enclosed 8 Indian Postal Order bearing nos. 53F 561118 (Rs.10/-), & 53F 561117 (Rs.10/-), 96G 424509 (Rs.50/-), 53F 561119 (Rs.10/-), 49F 820310 (Rs.10/-), 49F 820309 (Rs.10/-), 53F 561120 (Rs.10/-), 49F 820307 (Rs.10/-), (Total Rs.120/-) which are being returned herewith, in original.




