This appeal has been preferred u/s. 19 (1) of the RTI Act., 2005 by the appellant Mr. Chunnilal Joshi being aggrieved by the order passed by the State Public Information Officer, High Court of M.P., Bench at Indore dated 07/05/2025 by which applicant was provided with partial information.

Appellant has sought following information by his application dated 24/04/2025 filed before SPIO :-

*"न. एडमिन/250-ए पार्ट - अपील चुन्नीलाल जोशी वि. प्रधान जिला एव सत्र न्यायाधीश महोदय, इंदौर में पारित आदेश दिनांक 08/03/2025 तथा इसमें पारित समस्त नोट शीट की प्रमाणित प्रदान करने की कृपा करें"*

In turn, SPIO has given certified copies of 05 pages containing certified copy of order dated 08/03/2025 passed by Hon'ble Administrative Judge, Bench Indore (04 pages) and certified copy of office order dated 23/03/2025 issued by Principal Registrar dated 26/03/2025 containing endorsement of order of Hon'ble Administrative Judge.

Heard applicant Chunnilal Joshi today i.e. on 29.05.2025 and perused the reply/written arguments filed by SPIO.

Perused the order of SPIO which reveals that SPIO has given only certified copies of order of Hon'ble Administrative Judge (**04 pages**) and endorsement order of that order (**01 page**). It seems that SPIO has provided the details which was available to her end.


There is no any reason found that as to why complete information was not given.

In this matter, there is no bar of section 8 and 9 of RTI Act and there is no reason for giving the incomplete information to the applicant.

So, on the above discussion, I found that applicant should be given complete information. Thus appeal is allowed and authority is directed to give complete information to the applicant (**if available in records**) as per rules.

Copy of this order be sent to Joint Registrar (M), High Court of M.P., Bench at Indore for necessary action and information. A copy of this order be also provided free of cost to the appellant/applicant and also to the SPIO for information and necessary action.

As per Section 19(3) of the RTI Act, 2005, appellant/applicant may file an appeal to the Hon'ble Appellate Authority (State Information Commission, Bhopal) within 90 days of the issuance of this order.
