- 3.1 All the items will be disposed off in one lot to the successful bidder and no part bids shall be entertained.
- 3.2 The bidders may inspect the items on the days given in the auction notice and satisfy themselves of the items that for they are bidding.
- 3.3 The items shall be sold / auction to the **Highest Bidder (H-1)**.
- 3.4 The Earnest Money Deposit (EMD) of the successful bidder shall be adjusted in the bid forthwith.
