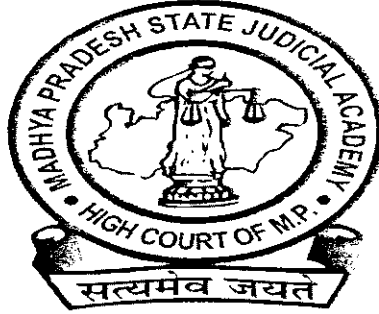

Terms & Conditions :

- 1- Fax/e-mail/telex & incomplete quotations will be rejected.
- 2- Registrar General, High Court of MP, Jabalpur has absolute right to accept or reject any or all quotations in part or full without assigning any reason whatsoever or any notice.
- 3- Any conditions/terms given in the quotation repugnant to the notice inviting quotations shall not be binding on the MPSJA.
- 4- The rate quoted for Annual Maintenance Contract (AMC) must be inclusive of all taxes, levies and expenses.
- 5- The successful vendor shall have to furnish a performance guarantee of Rs. 10,000/- in form of Demand Draft/irrevocable Bank Guarantee drawn in favour of Registrar General, High Court of Madhya Pradesh. The performance guarantee shall be returned after the expiry of one month from the date of termination the contract.
- 6- The successful vendor has to execute an Annual Maintenance Contract (AMC) which shall be valid for a period of one year from the date of execution of contract. All the expences of execution of the contract including the costa of stamp shall be borne by the successful vendor.
- 7- The AMC shall include one time replacement of all kinds of filters including **activated carbon, carbon block, membrane and pre-filter candle etc.**

- 8- The replacement of candles and filters shall be made during the contract period as and when felt necessary on the directions of the Director, MPSJA.
- 9- The AMC shall also include free replacement of wornout or exhausted parts including all electrical parts such as transformer kit or PCB and rectified spares during the periodical servicing or breakdown visit during the service contract period.
- 10- The successful vendor shall have to attend the Academy periodically in every three months for inspection and requisite service of the Water Purifier-cum-Water Coolers and shall have to maintain the record of TDS of water purifiers at the reception of Academy.
- 11- The successful vendor shall be further required to attend the Academy in case of breakdown of the machines when called upon to do so. Maximum time to resolve the issue shall be 48 hours.
- 12- In case of failure of the successful vendor in either attending the Academy on call log or in case of non-resolution of the defect/issue within 48 hours, the Academy shall be free to get the machine(s) repaired from outside the contract and the expenses shall be recoverable from the performance guarantee. The Academy shall also be free to take further action against the vendor as per law for the time being in force.
- 13- Payment will be made in advance after the execution of contract, subject to availability of funds.
- 14- The rates quoted for AMC is not subject to change in any condition.
- 15- The contract may be extended on mutual agreement of both the parties for a further period of one year, if approved by the competent authority.
- 16- This is an invitation to offer. No contractual relation is incurred by it.
