3.1 For participation in e-tendering module, it is mandatory for prospective bidders to get registration on website www.mptenders.gov.in Therefore, it is advised to all prospective bidders to get registration by making on line registration fees payment at the earliest.

3.3 Service and gateway charges shall be borne by the bidders.

3.13 *The firms registered under NSIC and MSME (The vendor to be registered with both NSIC and MSME for claiming exemption of tender fees) are exempted for submission of tender fees only. But they have to submit valid EMD as per the tender requirement.*

4. TERMS & CONDITIONS:-

- 4.1** Price quoted should be inclusive of all applicable taxes and levies.
- 4.2** The Registrar General reserves the right to change the quantity as per its requirement at any stage. Further the Registrar General reserves the right to place order either of all the items or only some of above items. The supplier shall have no right to claim any compensation in such case.
- 4.3.** Delivery should be within one month from the date of receipt of order for supply.
- 4.4** Sealed tenders should reach on or before date as mentioned above.
- 4.5** The Registrar General, High Court of Madhya Pradesh reserves the right to reject any or all tenders without specifying any reasons thereof.
- 4.6** In case of delay, penalty at the rate of 0.5% per day of the ordered value shall be charged (maximum penalty up to 5% of the order value can be deducted). If the delay is more than fifteen days the order shall stand cancelled.
- 4.7** Payment will be done after successful installation.
- 4.8** All disputes should be within the Jurisdiction of Jabalpur.
- 4.9** The vendor has to submit documentary proof of GST, GST return and authorization letter / certificate to sell the items/ goods / Authorize Vendor Certificate.
- 4.10** No Advance payment shall be made by the High Court.

- 4.11** If the vendor does not supply the Software/ hardware as per the details given, no payment will be made.
- 4.12** Rates once submitted cannot be changed and valid for at least one year from the date of supply of Software/ Hardware
- 4.13** The proposal should be submitted along with online application fee of Rs.5,000/- (Rupees Five Thousand only) and online Earnest Money Deposit (EMD) of Rs.5,00,000/- (Rupees Five Lakh Only) in the form of online mode through e-procurement tender portal www.mptenders.gov.in in favour of “Registrar General, High Court of Madhya Pradesh, Jabalpur” valid for the period of 6 months. The Bid submitted without EMD and/or the application fee/tender fees shall be summarily rejected.
- 4.14** All the documents should be placed in a single sealed cover superscribed as “**Purchase of Computer Hardware Articles and Operating System**” bid from: “M/s _____” “NOT TO BE OPENED BEFORE **11:00 A.M. on 24th July, 2024**”, which will be received as time mentioned in the tender. The Bid is to be submitted to the “Inward / Receipt Section of the High Court of M.P., Jabalpur”.
- 4.15** **ARBITRATION:-**
- In the event of any dispute or difference arising out or touching upon any of the terms and conditions of this contract and / or in relation to the implementation or interpretation hereof, the same shall be resolved initially by mutual discussion and conciliation but in the event of failure thereof, the same shall be referred to the Registrar General, High Court of Madhya Pradesh or his nominee. The sole arbitrator will be appointed by Hon’ble the Chief Justice, High Court of M.P. and the decision of the Arbitrator shall be final and binding on the parties. The arbitration shall be in Jabalpur and the Arbitrator

shall give his award in accordance with “The Arbitration and Conciliation Act, 1996”.

4.16 GOVERNING LAWS AND JURISDICTION:-

The Agreement shall be governed by the laws in force in India. Any dispute arising in relation to the Agreement shall be subject to the Jurisdiction of the Court at Jabalpur.

4.17 FORCE MAJEURE:-

4.17.1 Neither party shall be responsible to the other for any delay or failure in performance of its obligations due to any occurrence commonly known as Force Majeure which is beyond the control of any of the parties, including, but without limited to, fire, flood, explosion, Acts of God or any governmental body, public disorder, riots, embargoes, or strikes, acts of military authority, epidemics, strikes, lockouts or other labour disputes, insurrections, civil commotion, war, enemy actions.

4.17.2 If a Force Majeure arises, the Bidder shall promptly notify the Registrar General, High Court of Madhya Pradesh in writing of such condition and the cause thereof. Unless otherwise directed by the Registrar General, High Court of Madhya Pradesh the Bidder shall continue to perform his obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. The Bidder shall be excused from performance of his obligations in whole or part as long as such causes, circumstances or events shall continue to prevent or delay such performance.

4.18 PERFORMANCE BANK GUARANTEE:-

The Successful Bidder will be required to furnish performance bank guarantee in the form of unconditional Bank Guarantee issued by a Nationalized / Scheduled Bank in India as follows:
