**The Terms & Conditions for Comprehensive AMC for
RO WATER PURIFIER
in the High Court of Madhya Pradesh, Bench at Indore.**

1. The firm will start working immediately after award of the contract.
2. The firm will maintain the ROs as it is and where it is basis and will not charge extra money for any repairs or parts.
3. Beside the prevative maintenance the firm will attend and resolve to all complaints on receipt of information about breakdown/repair from the Registry directly. The services would be provided on regular basis during day time and in case of emergency beyond working hours including holidays on priority basis.
4. Filter/candle and Membranes must be replaced quarterly as per norms.
5. It may be ensured that the rates for parts of authorized brand or of standard quality only will be separately mentioned in quotation.
6. The Registry has the rights to terminate this AMC at any time without assigning any reason what so ever, if the services are found to be unsatisfactory.
7. The rates quoted will remain valid for three years from the date of acceptance of this Registry award of contract, yearwise breakup of rates must be mentioned in quotation with GST.
8. The firm must have experience of at least 02 years in the maintenance of ROs/Water purifiers. Proof of experience must be enclosed with quotation.
9. The vendor must furnish details of GST No. and PAN No..
10. Successful vendor should submit 5% amount of the contract as security amount along with the acceptance of condition on Rs. 500 stamp paper for execution of agreement.
11. In case of any dispute, final decision of Principal Registrar Indore Bnech Registry will be binding on the vendor.
