#### 1. Instructions to the tenderers:-

Tenders will be invited in sealed envelope consisting of technical bid. The bid will be made and put in the sealed single "TENDERS containing envelope the title COMPREHENSIVE ANNUAL MAINTENANCE CONTRACT OF DIGITAL DISPLAY SYSTEM AT HIGH COURT OF MADHYA PRADESH JABALPUR & BENCH AT INDORE AND GWALIOR." and addressed to the "Registrar General, High Court of Madhya Pradesh, Jabalpur" and the bid will be submitted in the Inward/ Receipt Section at the High Court of Madhya Pradesh, Jabalpur latest by 28th March, 2019 at 05:00 P.M. The tender will be open on 29th March, 2019 at 11:00 A.M.

#### 2. Period of Contract:-

The maintenance contract will be initially for a period of one year which can be extended further on mutual agreement subject to satisfactory performance of the contractor and will also depend upon the price trend for the services/products in the market on the date of extension.

#### 3. Scope of Work:-

- 3.1. The place of performance will be High Court of Madhya Pradesh, Jabalpur & Bench at Indore and Gwalior.
- 3.2. It will be duty of the Contractor to have the credentials of the Service Engineers verified and certified.
- 3.3. It must be noted that number of items in Digital display system may increased or decreased at the sole discretion of the High Court of Madhya Pradesh. In that case, payment will increase/decrease in same proportionate.
- 3.4. Any other work of similar nature assigned by the High Court of Madhya Pradesh, Jabalpur.

#### 4. Duties and responsibilities:-

- 4.1 Vendor should attend to all the complaints, irrespective of its nature.
- 4.2 Protection of Digital display system & maintaining the Digital display system in perfect working condition.

- 4.3 To attend the complaints without fail within the shortest possible time and in no case shall exceed 2 working days down time.
- 4.4 To depute service engineer to check the Digital display system and rectify the problem immediately to make it functional.
- 4.5 To replace all such parts which are damaged and which cannot be repaired to keep the Digital display system in perfect working condition.
- 4.6 To use only <u>Genuine Original spare parts</u> of manufacturing company in the Digital display system.
- 4.7 To carry out preventive maintenance (PM) on six monthly basis of all the components of Digital display system and to submit the report to the Registrar General, High Court of M.P., Jabalpur accordingly.
- 4.8 To maintain extra inventory of hardware items for proper running of Digital display system.
- 4.9 To maintain highest order of integrity, moral and social responsibility and decorum of the High Court.

### 5. Eligibility Criteria :-

- 5.1. The Agency applying should possess valid Income Tax PAN No. and GST registration. The Agency should have a minimum experience of 03 years in providing Annual Maintenance of Digital display system/similar hardware in Central Government / State Government Departments/Public Sector Undertakings/ Autonomous Bodies/ reputed private organization.
- 5.2. The Tenderer must have an average annual turnover of Rs. 20 lakh during the last three years in the field of Display systems, panels, monitors etc.. Copies of the following documents should be submitted alongwith the Bid.
  - a. GST Registration and latest return.
  - b. Income Tax PAN No.
  - c. Income Tax Return for last three financial years.

d. Documents along with proof regarding Experience of 3 years in providing similar services in Central Government/State Government /Public Sector Undertakings/Autonomous Bodies/reputed private organization.

## 6. Evaluation of Bids:

- 6.1 The Techno-Commercial Bid and price Bid will be evaluated as a package simultaneously. It must satisfy all the terms and conditions mentioned in this document and must be accompanied by all the requisite documents.
- 6.2 Filling up of all the columns in Techno-Commercial Bid and Price Bid is compulsory.

### 7. Performance Guarantee (Security Deposit):-

The successful bidder shall give performance security in the form of Account Payee Demand Draft or unconditional Bank Guarantee from a Nationalized Bank / Scheduled Banks amounting to 10% of the total contractual value in favour of Registrar General, High Court of Madhya Pradesh, Jabalpur. Performance Security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the contractor firm including warranty obligations. The Security Deposit will be refunded only after the expiry of the contract. This deposit is liable to be forfeited, if during the period of contract the services of the contract are found to be unsatisfactory in any respect, and/or if any of the conditions of the contract is contravened/breached, an/or towards any damage caused due to negligence of the contractor or his employees. This forfeiture will be in addition to any action by the High Court of Madhya Pradesh that the contractor firm may invite upon themselves due to any of the reasons specified above.

#### 8. Other terms and conditions:-

8.1. The Registrar General, High Court of Madhya Pradesh,
Jabalpur has the right of accepting or rejecting any or all
tenders without specifying any reason(s) thereof. The

- Registrar General is under no obligation to accept the lowest tender.
- 8.2. There is no obligation on the part of the Registrar General, High Court of Madhya Pradesh to inform the unsuccessful Tenderer of the outcome of the Tender process and reasons for rejection of tender.
- 8.3. The successful contractor shall, during the validity of the contract, engage/depute Service Engineers to attend the complaints Digital display system.
- 8.4. Payment of contractual value, in appropriate proportion, shall be released every quarter (3 months) based on the performance of the vendor.
- 8.5. It shall be mandatory on firm to conduct routine checks to maintain the Digital display system in perfect working condition and to submit the routine check reports on six month basis to the Registrar General, High Court of M.P., Jabalpur.
- 8.6. In case of pecuniary loss suffered by any of the users/beneficiaries of the High Court of Madhya Pradesh attributed to the Contractor, the Registrar General, High Court of Madhya Pradesh will have the right to forfeit the Security Deposit and in case the Security Deposit falls short to match the pecuniary loss being insufficient, such balance will be recovered from the payments due to the Contractor.
- 8.7. The rates finally approved/accepted by the High Court of Madhya Pradesh, Jabalpur shall be valid for the whole of the contract tenure and no upward revision will be allowed under any circumstances whatsoever. However on introduction of new taxes / levies the rate shall be change in the same proportionate.
- 8.8. Under no circumstances, shall the successful firm appoint any sub-contractor or sub-lease the contract. If it is found that the contractor has violated these conditions, the contract will be terminated forthwith without any notice, by the Registrar General, High Court of Madhya Pradesh.

- 8.9. The contract can be terminated by the Registrar General High Court of Madhya Pradesh, Jabalpur at any time without assigning any reason if the work of the contractor is found unsatisfactory. In this respect, the decision of the Registrar General, High Court of Madhya Pradesh, Jabalpur will be final and binding on the contractor. The Registrar General, High Court of Madhya Pradesh, Jabalpur reserves the right to accept or reject any bid in whole or in part without assigning any reasons thereof.
- 8.10. The bills in triplicate for the services prepared on the basis of rates will have to be submitted in favour of The Registrar General, High Court of Madhya Pradesh, Jabalpur for effecting payment. No advance payment shall be made for the maintenance services.
- 8.11. The job carried out shall be to the satisfaction of the High Registrar General, High Court of Madhya Pradesh, Jabalpur after getting certification from the concerned District Judge and Judicial Officers failing which deductions @ 10% of the total bill shall be made. Depending upon the severity of negligence, the Registrar General, High Court of Madhya Pradesh reserves the right to blacklist the agency for a suitable period or from further participation in any of the jobs to be done for the High Court of Madhya Pradesh, Jabalpur. The decision of the Registrar General of the High Court of Madhya Pradesh shall be final and binding on the firm/agency.
- 8.12. Premature withdrawal of the Tender by the Tenderer shall make him liable for forfeiture of the earnest money (EMD).
- 8.13. All the pages of the tender document should be serially numbered and duly stamped and signed by the bidder.
- 8.14. A penalty of Rs.500/- per day will be imposed for nonattendance of Service Engineers after the call is registered with the vendor. In this regard, the decision of

- the Registrar General shall be conclusive and binding on the service provider.
- 8.15. The Registrar General, High Court of Madhya Pradesh, Jabalpur reserves the right to review the performance whenever so desires, and also to terminate the contract at any point of time during the tenure of the contract in case the performance and the service rendered by the contract firm is found to be unsatisfactory. The decision of the Registrar General shall be binding on the Contractor. Contract can also be terminated at any point of time if the above mentioned work is no more required.
- 8.16. The Registrar General, High Court of Madhya Pradesh,
  Jabalpur reserves the right to vary, amend or alter any
  terms and conditions of the Tender Document at the time
  of execution of the Annual Maintenance Contract.
