NOTICE INVITING QUOTATIONS

- (ii) The background of the certificate shall include the watermark photograph of the Academy. The photograph shall be provided by Academy.
- (iii) The name of the participant and course training shall be printed in diglot pattern as per the requirement of the training schedule, for every programme separately.
- (iv) The certificate can be kept partially ready in advance by printing the background and border. Names of the participants and training schedule, shall be printed as per requirement.

- (v) As the work involves urgency, the printed certificates must be supplied at short notice i.e. the next day after order for the same is placed for every training/programme.
- (vi) Interested vendors may visit Academy to see the approved sample of Certificate.
