## Instructions to the Bidder:

Tender will be invited in sealed envelope consisting of Techno-commercial & Price Bid. The bid will be made and put in the sealed single envelope containing the title "TENDER FOR running the Shop for Copying Maching measuring about 10x10 Feet, in the Service Building of District Court Building Ujjain, M.P. and addressed to the District & Session Judge, Ujjain and the Bid will be submitted to the Office of The District & Session Judge, Ujjain. Madhya Pradesh latest by 18-11-2019. The Tender will be opened on 20-11-2019 at 05.00 to 05.30 p.m. in Conference Hall First Floor of court building. The bidder shall clearly specify Material/Services in shop will be covered under the services. All the remaining items/services shall not be treated as covered under the operation services.

### Terms and Conditions:

- 01. The period of contract shall be for a period of one year from the date of issue of contract the contract can be extended further 05 years with the approval of competent authority, Subjected to satisfactory performance of the Contractor.
- 02. The Bidder/Licensee shall have to pay Minimum Rs. 10,000/(Ten thousand only) as yearly license fee, by Demand draft issued in favour of 'The District & Sessions Judge Ujjain' payable at any nationalized bank at Ujjain. The tender shall be accepted amongst the bidder who will bid highest amount for yearly license fee.
- 03. The Licensee shall pay to the licensor such monthly amount of Rs, 1807/- as rent fixed by Rent Controlling Authority (subjected to change the rent in future) which have to be paid in advance for each month on or before the 7th day of each month. However, the licensee is required to pay 3 month rent in advance at the time of taking over the possession.

- O4. The bidder should have minimum two year's experience of running the Shop for providing services of Copying Machine, in Government Semi-Government Organization or public / private institution/ organizations etc. The relevant paper in regard of experience should be attached along with tender.
- 05. The electricity charges shall be paid as per actual consumption by the bidder/vendor at the prevailing rates or at such higher rates as may be decided by the competent authority from time to time.
- 06. The licensee will have to pay penalty Rs.100/- per day, maximum. Rs. 2500/- per month for late payment of rent, non hygiene and non sanitation of premises.
- 07. The licensee shall have no right to sub-let, assign or authorize any other person to run the shop.
- 08. The licensee shall be responsible for the maintenance of shop area in an absolute clean and hygienic condition at all times and will be responsible for payment of any/all the fine/ challans etc. imposed by competent authority or/and the District & Sessions Judge, Ujjain.
- 09. The licensee will obtain a legal certificate/license from the Municipal Corporation and other competent authorities required for running the shop.
- 10. The licensee shall have no right on the open space adjoining the shop.
- 11. The licensee shall be deemed to be in the exclusive occupation of the licensed premises/area and the licensor will have the right to enter upon the premises at any time during working hours to inspect the shop premises.

- 12. The Quality of material to be used and sold by the contractor should be of good/standard quality, which may be checked from time to time and if found unsatisfactory the license may be canceled, at any time, by the licensor/District Judge Ujjain. Without any previous notice and without assigning any reason. The District & Sessions Judge, Ujjain reserves all the rights to impose a fine, if deemed necessary even without any notice.
- 13. The Licensee shall have to specify the services to be provided and materials to be sold in the shop and rate thereof, the list of which shall have to be attached by the bidder/licensee with tender document.
- 14. The Photocopy stationary papers etc shall always be maintained in good condition and should also be of good quality
- 15. The Shop premises will not be used for residential purpose. No worker or person will be allowed to stay/work in the night in the shop without written permission of District & Sessions Judge Ujjain.
- 16. The conduct/characters/ of the workers in the shops shall be solely responsibility of the shop contractor. However, the licensee should provide the necessary details of employees to the District & Sessions Judge, Ujjain.
- 17. The Licensee should maintain punctuality in providing services at any cost. The licensee will also have to make special arrangement for providing services in the shop as and when required by the District & Sessions Judge. Ujjain.
- 18. The licensee shall maintain the licensed premises in good condition and shall not cause any damage thereto. If any damage is caused to the premises by the Licensee or his workers, employees or supplier the same shall be repaired by the licensee at his own cost either by rectifying the damage or by paying cash compensation as may be determined by the licensor.

- 18-A Any loss or damage caused by any natural calamity or negligence of bidder or its employees shall be charged from the bidder.
- 19. The licensed premises shall be used only for carrying on the business mentioned in this tender document and for no other purpose.
- 20. The licensee shall not cause any nuisance, annoyance to the customer and staff.
- 21. The licensee will install firefighting equipment in the shop as per Fire Regulation and keep the premises harmless and indemnify against any damage arising on account of fire, theft or negligence on the part of the licensee or his staff, to any property or staff. Such loss or damage shall be made good at the cost of the licensee and he shall be responsible for all other legal actions as per law.
- 22. The licensee shall not carry out any addition or alteration or structural repairs in the said premises. Only such alteration or additions or repairs which are necessary and are not of permanent nature may be allowed to be carried out by the licensee but that also with the prior approval/permission of the licensor.
- 23. The shop timing shall be from 10.00 a.m. to 7.00 p.m. or as directed by District and Sessions Judge, Ujjain on all working days. In holidays shop will be open as when required by the District Judge Ujjain.
- 24. The earnest money, advance rent may be forfeited, adjusted in case the standard of cleanliness, quality of products and services are not maintained up to mark and in the case of non-payment of office dues.
- 25. After opening the tenders the committee may visit the sites and may check the shop and items and kind of services and rates as specified by the tenderer in support of working experience.
- 26. The decision of licensor/District Judge ujjain in the matters relating to the Shop shall be final and binding on the licensee.

- 27. The licensor or his authorized representative has the right to visit the Shop at any time so as to verify & ensure that the licencee is using shops as per condition.
- 28. Licensor and licensee both may leave the contract at any point of time during the period of the contract after giving one month prior notice.
- On the expiry of the said term or period of license or earlier termination thereof, the licensee shall hand over peacefully the vacant possession of the licensed premises to the licensor in the same condition in which the premises now exist subject to normal wear and tear. The licensee's occupation of the premises after such termination will be deemed to be that of a trespasser and he shall further be liable to pay damages and the District Judge Ujjain or the person authorized by him, in this behalf, shall have right to eject the licensee from and take possession of the said premises, without any previous notice.
- 30. The licensee/contractor shall keep a complaint book which shall be made available by the licensee/contractor to any person who desires to record any complaint and which shall be opened to inspection by the District & Sessions Judge, Ujjain & other office/person deputed him, in this behalf.
- 31. The successful bidder shall have the deposit as sum of Rs. 5000/- as performance guarantee, in the form of Bank Draft in favour of District and Sessions Judge, Ujjain. The security deposit will be refunded after sixty days from the date of successful completion of the contract period and no interest would be paid thereon. In case of any damage or loss occurs, on account of the bidder or its employees, shall be forfeited from the performance guarantee.

Tender will be opened on 20-11-2019 at 05.00 to 05.30 p.m. conference room at first floor of District Court Building, Ujjain in presence of intending tenderers/ their representatives, if any. If for any administrative reason the date of opening of the tenders will be a declared holiday. The tender will be open on the next working day at the same time and place. If the tender could not be opened of the date of opening due to any unavoidable circumstances such as riotes, commotions, strikes heavy torrential rain leading to massive water logging etc. that shall be indicated along with the received date of opening of tender in the institute website which may be checked.

#### Arbitration:-

Except where otherwise provided for in the contract all questions and disputes relating to the instructions herein before mentioned and as to the quality of workmanship or materials used on the work or as to any other question, claim, right, matter or thing whatsoever in any way arising out of or relating to the contract, estimates, instructions, orders or these conditions or otherwise concerning the work or the execution or failure to execute the same whether arising during the progress of the work or after the completion or abandonment thereof shall be referred to the sole arbitrator as may be appointed by the authority of The District Judge, Ujjain. There will be no objection if the arbitrator so appointed is an employee of District Court and that he had no deal with the matter to which the contract relates and that in the course of his duties as such he had expressed views on all or any of the matters of disputes or difference. The arbitrator to whom the matter is originally referred being transferred or vacated his office or being to act for any reason, the appointing authority for arbitrator as aforesaid at the time of such an office or inability to act. shall appoint another person to act as arbitrator in accordance with the terms of the contract. Such person shall be entitled to proceed with the reference from the stage at which it was left by his predecessor. It is also term of this contract that no person, other than a person appointed by the such authority mentioned above shall act as arbitrator and if for any reason that is not possible, the matter is not to be referred to arbitration at all.
