- Only those firms shall be considered eligible who is having more than 05 years of experience in providing technical manpower services of pure IT technical persons.
- 2. In case of 02 firms who have quoted the same percentage of commissions in the financial bid, then under such circumstances the experience, turnover and size of organization / firm shall be taken into consideration for finalization of the bid by the High Court.
- 3. The manpower deployed shall be initially for the period of 01 year and the services can be extended for further one year depending of the satisfactory performance of the vendor and further approval by the High Court.

- 4. All the pages of the bids and "Annexures" are to be sealed and signed by the authorized officer of the company / vendor.
- 5. It will be duty of the service provider to make the payment to the technical manpower latest by 07<sup>th</sup> of every month.
- 6. The technical manpower that are deployed under the project shall have no relation of employee and employer with the High Court and under all circumstances the vendor / services provider shall be liable for their services, terms and condition.
- 7. The Registrar General, High Court of Madhya Pradesh has full rights to accept or reject any bid, without assigning any reason.
- 8. The Registrar General, High Court of Madhya Pradesh has right to alter the scope of work as per the requirement or change the monthly remuneration.
- 9. All Prospective bidders are requested to submit the bid with <u>all</u> relevant documents in hard bound with proper indexing, otherwise the bid shall not be consider by the High Court.
- 10. The technical bid of the tender document along with EMD is to be submitted to Inward / Receipt Section of the High Court of M.P., Jabalpur before due date and time.
- 11. The financial bids of the tender are to be submitted online only.

  No hardcopy of the financial bid is to be submitted along with the tender document.
