- The specifications mentioned in tender document are minimum and vendor can quote higher or better specification for the supply of servers at High Court and Subordinate Courts in the State of Madhya Pradesh.
- 2. The total price of commercial bid inclusive of all taxes & expenses for 5 (Five) years on-site maintenance & support shall be taken as the basis for evaluation of commercial bids. <u>In case of any discrepancy in the tax factor, the basic product price shall be taken into consideration for finalization of bids.</u>
- 3. The number of servers may increase depending upon the final requirement of the High Court/ District Courts.
- 4. The firms / vendors registered under <u>NSIC are exempted</u> for submission of tender fees and EMD but they have to submit valid document in this regard to the High Court as per the tender document.
- 5. The bidder has to quote only 01 product of single make / brand at a time and not multiple brands for same item.
- 6. The Original equipment manufacturer (OEM) may authorize more than one partner for participation in the bid.
- 7. Back-to-Back <u>support letter</u> is to be submitted by OEM regarding support of their quoted servers.
- 8. The Registrar General, High Court of Madhya Pradesh has full right to accept or reject any bid, without assigning any reason thereof.
- 9. All Prospective bidders are requested to submit the bid with all relevant documents and product brochures / catalogues. In case of any technical deviation / variation the vendors are requested to mention the same in the bid document.
- On introduction of new levy / taxes / duties the price of items shall change in same proportionate.
