2	For Data entry operators, office assistants and helpers you have mentioned as per MP Govt. Norms can you please say what was their wage per day	As per minimum wages act and norms of Government of Madhya Pradesh .The data entry operator, office assistant shall be under skilled category and the helpers shall be under unskilled category. However, the decision in this regard shall be final by the High Court.
3	And in the financial bid you produced a column monthly % per person & percentage of Service charge / commission of service provider. (quote in % only) for this can we put different percentages for different categories or it should be same percentage for every category.
