The Bid submitted without EMD and/or the application fee shall be summarily rejected. The bid sealed in a single envelope, superscribing "Bid for supply of Reinforced Concrete Benches for the District Courts of Madhya Pradesh" addressed to "Registrar General, High Court of M.P., Jabalpur. No editing, addition/deletion of the matter is permitted, if such action is observed at any stage, such tenders are liable for outright rejection and <a href="suitable-legal">suitable-legal</a> action will be taken against the bidder.
- Only enclosed formats as provided in original should be used. All sheets need to be submitted after affixing seal of the Company and signature of the authorized signatory. Additional sheets, duly authenticated, may be attached to elucidated specifications or clarify the specific issues.
- 4. The prescribed tender document consisting of (i) Technical Bid along with EMD and tender fees superscribing "Bid for supply of Reinforced Concrete Benches for the District Courts of Madhya Pradesh" is to be submitted to the High Court of Madhya Pradesh, Jabalpur before due date and time.
- 5. Tender document should be signed and stamped by the bidder on each page accepting the terms and conditions of the tender.
- 6. Tenderer has to submit online EMD of Rs. 2,50,000/-(Rupees Two Lakh Fifty Thousand only) and tender fees of Rs.5,000/-(Rupees Five Thousand only). Tenders received without EMD and tender fees shall be summarily rejected. The EMD shall be refunded (without interest) after the execution of the bid.
- 7. The Registrar General, High Court of M.P. reserves the right to forfeit the EMD amount on non-acceptance/non-compliance of offer in full or part or if it is found that tenderer has misrepresented in any way.
- 8. Reinforced Concrete Benches can be supplied by the manufacturer directly or through their authorized resellers /

- partners /dealers. However, the authorization letter from the manufacturer/parent company is to be enclosed along with the bid document for the supply of Reinforced Concrete Benches.
- 9. The bidder shall quote the prices of items including all taxes, levies or other transportation charges. No price revision/alternative will be allowed after the receipt of the Bid. However in case of introduction of new taxes/ levies, the rate shall change in same proportionate.
- 10. All prices and other information in this regard having a bearing on the price shall be written both in figures and words in the prescribed offer form.
- 11. Any conditions/terms given in the bid by bidder shall not be binding on the High Court of M.P., Jabalpur. All the terms and conditions for the supply, delivery, payment, warranty, penalty, etc. will be as given herein and no change in any term or condition by the vendors will be acceptable.
- 12. Canvassing in any form will be viewed seriously and if any Tenderer is found to be resorting to such practice, the Tender of such firm will be rejected.
- 13. The bidder should quote only for the specific type as mentioned in the tender document.
- 14. The cost quoted should include the cost of installation, transportation and other necessary requirements.
- 15. Against bidders compliance column in technical specifications, only **Yes/No**, as the case may be, should be mentioned.

#### **CONDITIONS OF CONTRACT**

- Tenderer should have at least three years of experience in the sales of Reinforced Concrete Benches or similar Cement Concrete Structure.
- 2. Tenderer should have average turnover of minimum Rupees

  Fifty Lakh during last three years in the sale of Reinforced



- Reinforced Concrete Benches as per the specifications need to be delivered and installed at <u>District Courts in the State of</u> <u>Madhya Pradesh.</u>
- Tenderer should enclose the copies of valid GST registration,
   PAN No., GST Return and other relevant document as per the tender document.
- The Reinforced Concrete Benches should conform to the standard (s) as mentioned in <u>Chapter-3</u>. Documentary proof of the same should be attached along with the tender document.
- 6. In case of any discrepancy between the unit price and the total price, the unit price shall prevail and total price shall be corrected unless it is lower than the sum total of unit prices. If there is any variation between the amount written in figures and words, then the amount whichever is lower shall be taken into consideration.
- 7. Delivery and installation period: **Maximum three months** from the date of receiving the Work Order.
- 8. Successful Tenderer will have to furnish the Contract Form and unconditional Bank Guarantee valid for the period of Five years to the High Court of M.P., Jabalpur within 15 working days from the date of issue of Purchase Order, failing which the purchase order shall stand cancelled and EMD shall be forfeited.

- 9. Successful Tenderer will have to adhere to the <u>delivery</u> <u>schedule strictly</u>. The Registrar General, High Court of M.P., Jabalpur reserves the right to cancel the purchase order and forfeit the EMD, if purchase order is not executed within the stipulated time and to place the order with the next successive bidder.
- 10. Payment terms: 100% on delivery and installation.
- 11. The supplier's request for payment shall be made in writing accompanied by relevant document such as proper invoice, delivery challans and successful installation reports duly signed by authorized official of the District Court.
- 12. The vendor has to maintain the benches for the minimum period of three years.
- 13. Security Deposit (SD) / performance Bank Guarantee (PBG): SD / PBG will be 10% of the purchase order value. The security deposit to be in the form of unconditional Bank Guarantee / FDR of Nationalized Bank/Scheduled Bank valid for the period of three years.
- 14. The Registrar General, High Court of M.P., Jabalpur reserve the Right to accept or reject any offers without assigning any reason thereof, and to amend the terms and conditions before award of the contract.
- 15. Any disputes arising out of this tender shall be under the <u>Jurisdiction of Court of Jabalpur only</u>.

## **Specification Details**

#### SPECIFICATION FOR PRECAST CONCRETE REINFORCED BENCH



- Description: This bench shall govern the provision of supply, erecting and installation of precast concrete reinforced benches with back rest at the District Courts & Tehsil Courts in the State of Madhya Pradesh.
- 2. General Requirement: The precast concrete reinforced benches shall be manufactured in accordance with the design requirements and details shown in the plan, and in conformity with the requirements of this specification as per details given below.
- 3. Materials and Construction Methods: The material and construction of precast concrete reinforced benches shall be as follows:
  - i. Concrete Mix Design: The benches shall be cast using M-30 Grade concrete mix in accordance with IS:10269: 2009 (with latest amendment) in gay cement by using vibro-compaction technique and with reinforcement as detailed in this specification. The manufacturer shall be responsible to design a mix which achieves both the strength and the surface finish required for the installation and application. Compressive strength shall be not less than 30 MPa at 28 days.
  - ii. **Reinforcement Steel:** TMT reinforcement bars confirming to IS: 1786:2008 of dia 10 mm shall be used as main reinforcement bar

- and 4 mm dia mild steel bars shall be used as stirrups as per reinforcement diagram.
- iii. **Connections:** 12mm dia x 65 mm long galvanized steel CSK (Countersunk) bolts with EVA (Ethylene Vinyl Acetate) washer for connecting seating plank with leg and half threaded carriage bolts & nuts with EVA & steel washers of size 165mm length x 8mm dia for connecting back rest plank with leg. Threaded steel fastener shall confirm to IS:1367 with latest amendments.
- iv. Acrylic Paint: Green / Blue / Red acrylic based pain confirming to IS":15489 should be used. The color combination shall be decided by the Committee of the High Court.

#### 4. Details of member of precast concrete reinforced bench:

- i. RCC Base Supports: Two number of legs manufactured using M-30 grade grey cement concrete of back height 1000mm, front height 400mm, bottom width 620mm with 100mm thickness. Each leg shall be reinforced with 4 nos. of 10mm dia TMT bars distributed uniformly along the section and periphery of the legs and tied with 4mm dia mild steel stirrups as per detailed given in drawing. Each leg will have 3 nos. 12mm dia 65mm length galvanized coupling nuts, welded suitably to the main reinforcement at appropriate locations on the seating to receive concrete planks on the legs and 3 holes to receive carriage bolts for fixing back rest planks.
- ii. Planks: Five RCC planks of size 1500 mm x 100mm x 50 mm shall be cast using M-30 Grade grey cement mixed with 3% red pigment (Other color may be used, if decided by Engineer) and each plank reinforced with 2 nos. 10mm dia TMT bars along the length and 10 nos. 4 mm dia mild steel bars along the width and having 2 holes of 14mm dia at appropriate location to receive 12mm dia galvanized bolts for fixing these planks on the legs. One RCC plank of size 1500mm x 200mm x 50mm shall be cast using M-30 grade grey cement concrete mix with 3% red pigment (Other color may be use, if decided by Engineer) and shall be reinforced with 3 nos. 10mm dia TMT bars along the length as per drawing and 10nos. 4mm dia mild steel bars along the width and having two holes of 14mm dia at appropriate location so as to receive 12 mm dia galvanized bolts for fixing on the legs.
- **5. Finish:** Finish of concrete bench shall be generally equal to the approved sample. Exposed surface should exhibit a typically uniformly smooth texture with no bugholes and smooth mold seams.
- **6. Tolerances:** All dimensions should be as per drawing <u>+</u> 3mm.

#### 7. Product Delivery, Handling and Storage

- Deliver materials to site, ready for use in the accepted manufacturer's original and unopened containers and packaging, bearing labels as type of material, brand name/manufacturer's name.
- ii. Store materials under cover in a dry and clean location, off the ground. Remove delivered materials which are damaged or otherwise not suitable for installation from job site, and replace with acceptable materials as directed by the engineer.
- iii. The Benches to be delivered at District and Tehsil Courts in the state of Madhya Pradesh.
- 8. Installation of RCC bench: Each seating plank (bottom) of bench will be bolted with the leg with the help of 12 dia x 65mm length galvanized steel CSK (Countersunk) bolts with EVA (Ethylene Vinyl Acetate) washer. Back rest planks will be fitted with half threaded carriage bolts and nuts with EVA and steel washers of size 162mm length x 8mm dia.
  - After assembly of legs and planks at site, the hole visible at the back side of the bench will be sealed with cement mortar to prevent pilferage and plank will be painted with red / blue/ green color acrylic based paint. Head of bolts shall be grouted with epoxy resins like Araldite.
- **9. Measurement:** The unit of measurement shall be a complete bench.
