Subject :- Tender for supply/Installation of Furnitures in the District Court, Bhopal

Sealed quotations are invited for supply/ installation of furnitures in the District Court, Bhopal given below from Manufacturing Companies, reputed Vendors/Dealers, registered, bonafide, reputed, experienced and eligible firms who have executed similar nature of work in Court Premises/Government Ministries/ Departments, Semi-government organizations including Public Sector Undertakings and satisfying all other terms and conditions in this tender document.

Required Furnitures as follows :-

(1) Leoma High Back revolving chair (20 Nos.)

(SIZE:71 CM (W) x 71CM(D) x 115.5-131 cm(H) Seat Hight 45-54 POLYURETGHANE FOAM. The foam shall be moulded in density 75 +/- 4kg/m³, The armrest hight shall be adjustable upto 4.5+0.5 cm. in three steps and width adjustable up to 20 mm. Mehanism: 360° revoving type. Front pivot for tilt with feet resting on ground. The neck rest assembly shall be maounted on the top of back. It shall be adjustable.)

(2) Fixed Visitor Chair (50 Nos.)

The seat and back should be made up of 1.2 cm thick hot pressed plywood, upholstered with changeable fabric upholstery covers and moulded Polyurethane foam, together with moulded back-spine cover. The back foam should be designed with contoured lumbar support for extra comfort having back size of 47.5 cm.(W) x 58 cm.(H) & seat size 47.0 cm.(W) x 48.0 cm.(D). The Foam used in chair should be Polyurethane foam which shall be moulded wit ARMRET (The armrests shld be fitted to the seat with armrest brackets made of 0.5cm. thk. HR steel. Tubular Frame :- It should be powder coated cantilever type and made up of dia 25.4mm x 2mm thick M.S.ERW.Tube Overall dimensions of Chair should be Width- 61 cm, Depth- 64.5cm, Height- 89.5cm, Seat Height- 46.5cm.

(3) Sliding Glass door Unit (04 Nos.)

The sides and back of the storage should be made of 0.7 mm high yield strength CRCA sheet. The Top should be metal top. It should be in 1 Rigid Knock Down Construction. The size of the storage should be H 1830mm x W 900mm x D 450mm. It should have Glass Door for visibility of the content. The sliding door should have top hanging arrangement to prevent derailment. The storage should have height wise 4 adjustable shelf mounting with uniformly distributed load capacity of 40 Kg maximum. The Final finish should be Epoxy Polyester Powder coated to the thickness of 50 microns (+/- 10).

(4) Easy Rack (H2438 mmx W 905mm x D 448mm) (20 Nos.)

The Racks should be made of prime quality steel. The product should have even thickness of material and should have superior load carrying capability. It should be designed in accordance with IS:800 & IS:801 standards. All components should be subjected to a Five zone, 8 stage special pre-treatment process and finished using superior powder coating technology to give long lasting finish and anti corrosion properties. The size of the rack should be H 2438mm x D 448mm x W 905mm. The racks should have 8 panels and the rated capacity per panels should be 180 Kg. The rated capacity per rack should be 1100 Kg.

(5) Staff Table(W 1200mm x D 900mm x H 750mm) (20 Nos.)

The main table is of size 1200mm (W) x 900mm (D) x 750mm (H), with top thickness of 36 mm (18 mm PLT + 18 mm PLB baton). The top of main table is laminated with 2 mm lipping all around. Understructure is to be made of rectangular tube of size 40x20x1.6 mm thickness with CRMS 3 mm thick plates for bolting the leg. Modesty (front & side) is to be made of perforated MS sheet of 0.9 mm thickness. Legs are to be made from round tube of dia 50 x 1.6 mm thickness. Leveling screws to be provided. Drawer unit is to be made of MS sheet of thickness 0.8 mm / 0.90 mm. Size should be W - 390 mm x D - 590 mm x H - 646 mm.

(6) CPU Trolley (20 Nos.)

The CPU Trolley should have adjustable width of 150 - 225 mm and weight of 1.5 Kg. The material used should be CRCA Steel. The final finish should be Powder Coating and thickness should be 0.8 mm. It should have Lockable castors.

(7) Foot rest (70 Nos.)

The footrest should provide foot rest angle adjustable & should promote stress free posture, slip resistance surface and should have over all size of W- 445 mmx D- 295 mm.

(8) Display / Pin Up Board (04 Nos.)

The Core material of the Pin up board should be Particle board, middle surface should be made of soft board and upper layer made of Felt cloth, It should also Aluminium Framing with plastic corner caps and should be covered with transparent acrylic material with locking system. The Overall size should be 6 ft x 4 ft.

1. Instructions to the Tenderers:

Quotations will be invited in sealed envelope. The bid will be made and put in the sealed single envelope containing the title **“QUOTATIONS FOR SUPPLY/ INSTALLATION OF FURNITURES IN THE DISTRICT COURT, BHOPAL”** and addressed to **DISTRICT REGISTRAR, BHOPAL** and the Bid will be submitted to District Registrar, District Court, Bhopal latest by **01:00 PM on 30 July, 2016.** The Tender will be opened on **the same day at 3:30 p.m.**

Tender relates to 'supply/installation of furniture in the District Court, Bhopal'

The Tenderer shall clearly specify what items are not covered under his bid.

Scope of Work :

- i. The place of performance will be the District Court, Bhopal.
- ii. The Vendor shall supply and install reputed Furnitures only.

Terms and conditions :

The Vendor shall complete the supply/installation of furnitures within one month after the receipt of Order failing which a penalty of Rs.200/- per day shall be imposed.

Application form shall be available with the District Nazir, District Court, Bhopal during working hours. Tender document may also be downloaded from the official website of the M.P. High Court, Jabalpur i.e. www.mphc.in.

The quotation will be opened in the Office of the District Registrar, District Court, Bhopal at 03:30 PM on ...30.. **JULY, 2016..** One representative of the bidder may remain present. Quotations will be finalised after considering the proposals. All Tenderers or any of the Tenderer may be called for further negotiations before considering his/their proposal.

District Judge shall have absolute right to select/reject any quotation/quotationer for supply/installtion of furnitures on the basis of rate, quality and services proposed in the tender.

The applicant/vendor is required to submit Brochure(s)/Specification with complete details of the furnitures proposed to be supplied.

The District Judge, Bhopal has the right of accepting or rejecting any or all tenders without specifying any reason(s) thereof. The District Judge shall have right to cancel entire tender process without assigning any reason whatsoever. The District Judge, Bhopal is under no obligation to accept the lowest tender.

There is no obligation on the part of the District Judge, Bhopal to inform the unsuccessful Tenderer of the outcome of the Tender process and reasons for rejection of tender.

The District Judge, Bhopal reserves the right to accept single bid or direct for re-tender, in case, only one bid is received till last date of submission of bids.


The successful Vendor shall forthwith engage/depute technical person/Operators to install furnitures in the District Court, Bhopal.

Rates offered in the Tender shall be valid for a period of three months and once the tender is accepted, the rates will be enhanced in final payment tenure. No upward revision will be allowed under any circumstances whatsoever.

Under no circumstances, shall the successful firm appoint any sub-contractor or sub-lease the contract. If it is found that the contractor has violated these conditions, the contract will be terminated forthwith without any notice, by the authority who has approved the award of the contract.

The bills in triplicate for the services prepared on the basis of approved rates will have to be submitted in favour of the District Judge, Bhopal for effecting payment. No advance payment shall be made for the job.

- xiii. The job carried out shall be to the satisfaction of the District Judge, Bhopal after getting certification from the District Registrar **failing which deductions @ 10% of the total bill shall be made.** Depending upon the severity of negligence, the District Judge, Bhopal reserves the right to blacklist the agency for a suitable period or from further participation in any of the jobs to be done for the District Court, Bhopal. The decision of the District Judge, Bhopal shall be final and binding on the Firm.
- xiv. **All the pages of the tender document should be serially numbered and duly stamped and signed by the bidder.**
- xv. The District Judge, Bhopal reserves the right to vary, amend or alter any terms and conditions of the Tender Document at the time of placement of work Order.
