SCOPE OF WORK:-

Tender for 100 MBPS MPLS VPN connectivity at HIGH COURT OF M.P., Jabalpur and its Bench at Indore and Gwalior including installation, commissioning, testing & up keep of the complete link for entire two year of service period. The bidders are requested to visit High Court of M.P., Jabalpur and take survey of the existing infrastructure before formulating their bid.

TERMS AND CONDITIONS:-

1. IMPORTANT NOTES FOR VENDOR:-

The tenders are to be submitted as comprising Part-I:
Technical Commercial Bid & Part-II: Price Bid. The Part-I
(Techno-commercial) bid should contain the online EMD and online tender fees details. The envelope should properly mark and sealed envelopes for proper identification. "Superscribing the tender number & due date of opening". The Bid to be addressed to the "Registrar General, High Court of M.P., Jabalpur"

b) **EARNEST MONEY DEPOSIT (EMD):-**

The proposal should be submitted along with <u>only</u> online application fee of Rs.1,000/- (Rupees One Thousand only) and Earnest Money Deposit (EMD) of Rs.25,000/- (Rupees Twenty Five Thousand only) in the form of <u>online mode</u> through e-procurement tender portal <u>www.mptenders.gov.in</u> valid for the period of 6 month in favour of "Registrar General, High Court of Madhya Pradesh, Jabalpur". The Bid submitted without EMD and/or the application fee shall be summarily rejected. The EMD shall be refunded to unsuccessful tenderer, after finalization of the tender. EMD shall be forfeited if any tenderer withdraws his offer before finalization of the tender or fails to submit work order acceptance within 15 days from the date of work order.

- c) Bank Guarantee: An Performance Bank Guarantee of 10% of the total order value should be furnished by the successful vendor from any Nationalized/scheduled bank. The Performance Bank Guarantee shall be valid for the period of Three years from the date of installation & commissioning of the MPLS VPN connectivity and shall be released after the successful completion of the contract.
- d) All the pages of bids including the documents submitted therein must be duly signed and stamped, failing which the offer may be rejected.
- e) The validity of the offer is for **180 days** from the due date.
- f) The Registrar General, High Court of Madhya Pradesh reserves the right to cancel the tender without assigning any reason at any stage of the tender process.
- g) The Registrar General, High Court of Madhya Pradesh reserves the right to alter/modify any or all conditions of this tender notice, at any time including at the time of execution of contract
- 2. Qualifying condition for Eligible Bidder/Technical requirement:
- a) The Bidder must be a Class 'A' Service provider. The bidding company must have the requisite infrastructure and resources to successfully execute the Order and provide services at High Court of Madhya Pradesh. The bidder should have a valid category 'A' license from Govt. of India (Attach a copy of License).
- b) MPLS VPN Service Provider should have a fully functional customer service centre for all working days from 09:00 A.M. to 06:00 P.M.
- The Bidder should have at least two Government clients using MPLS VPN connectivity. <u>Client satisfaction certificate and</u>

contact person details must be enclosed.

- d) The tender should clearly indicate the different components of the total charges recurring (Annual) and non-recurring (One Time) including bandwidth and equipment proposed to be supplied with cost and details of charges and taxes.
- e) The vendor must undertake end-to-end responsibility with **99% uptime**. The SLA (Service Level Agreement) should be part of the proposal.
- f) The service provider will provide suitable software for monitoring and recording the uptime of MPLS VPN connectivity.
- g) The benefits of any drop in the charges/tariff of MPLS VPN port access during the contract period shall be passed on to Registrar General, High Court of Madhya Pradesh.
- h) All equipments including Router should be provided by the vendor as a part of proposal.
- i) The vendor must mention clearly the requirement of the Hardware and Software (Server, Operating Systems, etc.) to make this connectivity operational.
- j) The bidder not supplying the complete and correct information as above shall not be considered.
- k) Payment of one time charges, if any, shall be payable after successful installation and commissioning of the system and submission of bills in triplicate to the Registrar General, High Court of Madhya Pradesh. The recurring charges shall be released from the date of submission of bills in triplicate to the Registrar General, High Court of M.P., Jabalpur after completion of every quarter.
- Service delivery Period: The service delivery period i.e. installation & commissioning of the job shall be within four weeks from the date of issue of the work order.

- m) The bidder or his authorized representative and the representative of Registrar General, High Court of Madhya Pradesh shall carry out the inspection jointly after successful installation and commissioning of the services.
- n) The vendor shall carry out preventive maintenance on quarterly basis for upkeep of the system.
- o) The bidder shall move the equipments from one location to another location within High Court of Madhya Pradesh, if required, without any financial implications.
- p) The response time for attending the faults will be 30 minutes after they are reported to the vendor. The vendor will rectify the faults within 01 hours failing which for every 1% down time a month, whenever the uptime goes below 99 %, one extra full day service should be provided. If the uptime goes below 95%, the Registrar General, High Court of M.P. has the right of cancellation of work order and encashment of the bank guarantee without assigning any reason thereof.
- q) The 100 Mbps line is required presently for 3 locations only but there should be provision to increase the number of locations in future as per requirement.

3. SLA (Service Level Agreement)

The bidder should commit to a detailed SLA, which clearly outlines Bandwidth as well as Latency, and Drop Rate commitments. The SLA must also list out the commitments on service for Faults. Faults, if any, shall be attended to on immediate basis but in no case any fault should prolong for more than 1 hour.

WHEREAS the Registrar General, High Court of Madhya Pradesh is desirous of giving a job contract for providing 100
MBPS MPLS VPN connectivity on uncompressed, un-shared
basis
 arrangement at High Court of Madhya Pradesh Jabalpur and its benches at Indore & Gwalior and whereas the Contractor has offered to provide the above mentioned service on the terms and conditions hereinafter stated.

WHEREAS Contractor has represented that it is a registered /authorized MPLS VPN Service Provider registered with ______ and has further represented that he is eligible to get this contract and there is no legal or any other bar for him in this respect. Any obligations and/or formalities which are required to be fulfilled or any amendment thereto for the purpose of entering into and/or execution of this contract shall be carried out by the contractor at his own expenses, etc. and the contractor shall report the compliance thereof to the High Court of M.P., Jabalpur. The contractor shall be solely liable for any violation of the provisions of any Act or any other statutory provisions.

WHEREAS Registrar General, High Court of Madhya Pradesh has agreed to award the contract of 100 MBPS MPLS VPN on uncompressed, un-shared line (1:1) at High Court of Madhya Pradesh Jabalpur.

AND WHEREAS the contractor has agreed to furnish to the High Court of Madhya Pradesh deposit 10% of the amount by

way of Unconditional Bank Guarantee.

Now, Therefore By These Articles And On The Premises mentioned above, the parties have agreed to as under :-

A. GENERAL CONDITIONS

- 1. That it is expressly understood and agreed between the parties to this Agreement that the service of 100 MBPS MPLS VPN connectivity on uncompressed, unshared line (1:1) at High Court of Madhya Pradesh, Jabalpur and its benches at Indore & Gwalior for all intents and purposes shall remain under the control and supervision of the Registrar General, High Court of Madhya Pradesh, Jabalpur.
- 2. Hardware/software supplied should be with onsite comprehensive warranty for part of contract for all parts after satisfactory installation. The Contractor should maintain and repair the system during the warranty period free of cost. The defects, if any shall be attended to on immediate basis but in no case any defect should prolong for more than one hour.
- 3. The payment of MPLS VPN connectivity charges will be made on quarterly basis.
- 4. That on taking over the responsibility of providing MPLS VPN connectivity on uncompressed, unshared line, the contractor shall formulate the mechanism in consultation with Registrar General, High Court of Madhya Pradesh or his authorized officer to ensure that there is no loss of bandwidth and shall review from time to time and advise the Registrar General, High Court of Madhya Pradesh for further streamlining the MPLS VPN Service. The contractor shall further be bound by and carry out the directions/instructions given to him by the Registrar General, High Court of Madhya Pradesh or the officer designated by the Registrar General, High Court of Madhya Pradesh in this respect from time to time in connection with the service.

- 5. That the Registrar General, High Court of Madhya Pradesh or any other person authorized by him shall be at liberty to carry out surprise check on the service.
- 6. That in case the service provided by the contractor does not come up to the mark, the Contractor, shall take all necessary action to rectify the problem for optimal service.
- 7. The service provider will submit weekly status report of performance of MPLS VPN connectivity.

B. CONTRACTOR'S (SERVICE PROVIDER'S) OBLIGATIONS:-

- That the Service Provider shall provide 100 MBPS MPLS VPN connectivity on uncompressed, unshared line (1:1) at High Court of Madhya Pradesh Jabalpur and its benches at Indore & Gwalior.
- That the Service Provider must undertake end-to-end responsibility with 99% uptime. The SLA should be part of the proposal.
- 3. That the Service Provider shall provide suitable software for monitoring and recording the uptime for MPLS VPN line.
- 4. That the Service Provider shall provide router and other Hardware infrastructure.
- 5. That the Service Provider shall move the equipment from one location to another location within High Court of M.P., Jabalpur, if required, without any financial implications to Registrar General, High Court of Madhya Pradesh Jabalpur.
- 6. The response time for attending the faults will be half an hour (30 minutes) after they are reported to the Contractor (service provider). The Contractor will rectify the faults within 01 hours, failing which for every 1% down time a month, whenever the uptime goes below 99%, one extra full day

service should be provided. If the uptime goes below 90%, the Registrar General, High Court of Madhya Pradesh Jabalpur has the right of cancellation of work order and revocation of the bank guarantee.

C. PENALTIES / LIABILITIES

- That the contractor shall be responsible for faithful compliance of the terms and conditions of this agreement. In the event of any breach of the agreement, the same may be terminated and the security deposit will be forfeited and further the work may be got done from another agency.
- That if the contractor violates any of the terms and conditions of this agreement or commits any fault or their services are not to the entire satisfaction of officer authorized by the Registrar General, High Court of Madhya Pradesh Jabalpur a penalty leading to a deduction up to a maximum of 10% of the total amount of bill for a particular quarter shall be imposed.

D. COMMENCEMENT AND TERMINATION

- 2. That this agreement may be terminated on any of the following contingencies:
 - a) On the expiry of the contract period as stated above.
 - b) By giving one month's notice by Registrar General, High Court of M.P., Jabalpur on account of:
 - i) committing breach by the contractor of any of the terms and conditions of this agreement.

- ii) On assigning the contract or any part thereof to any subcontractor by the contractor without written permission Registrar General, High Court of Madhya Pradesh Jabalpur.
- iii) without assigning any reason.
- c) On contractor being declared insolvent by competent Court of Law.

During the notice period for termination of the contract, in the situation contemplated above, the contractor shall keep on discharging the service as before till the expiry of notice period.

It shall be the duty of the contractor to remove all the hardware and software, equipments installed by him on termination of the contract.

E. ARBITRATION

- In the event of any question, dispute/difference arising under the agreement or in connection herewith (except as to matters the decision of which is specially provided under this agreement) the same shall be referred to the sole arbitration to Registrar General, High Court of Madhya Pradesh Jabalpur.
- 2. The award of the arbitrator shall be final and binding on the parties. In the event of such arbitrator to whom the matter is originally referred is being transferred of vacating his office or resigning or refusing to work or neglecting his work or being unable to act for any reason whatsoever, the Registrar General, High Court of Madhya Pradesh Jabalpur shall appoint another person to act as arbitrator in place of the out-going arbitrator in accordance with the terms of this agreement and the persons so appointed shall be entitled to proceed with the reference from the stage at which it was left by his predecessor.

- 3. The Arbitrator may give interim award(s) and/or directions, as may be required.
- 4. Subject to the aforesaid provisions, the Arbitration & Conciliation Act, 1996 and the rules made hereunder and any modification thereof from time to time being in force shall be deemed to apply to the arbitration proceedings under this clause.
