

In exercise of the powers conferred under Article 235 of the Constitution of India, the High Court of Madhya Pradesh, hereby posts Shri Siddhartha Tiwari, VI District & Additional Sessions Judge, Mandsaur as In-charge Principal District Judge, Mandsaur in addition to his own duties, on temporary basis, from the date of assuming the charge by him.

Exercising the powers conferred under sub-section (5) of Section 8 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Number 46 of 2023), High Court of Madhya Pradesh appoints Shri Siddhartha Tiwari, as the In-charge Sessions Judge on temporary basis, from the date of assuming the charge in the Sessions Court.
