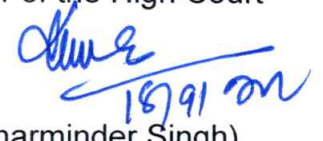

In exercise of the powers conferred under Article 235 of the Constitution of India, the High Court of Madhya Pradesh, hereby posts Smt. 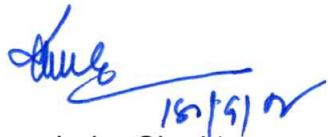
