

In exercise of the powers conferred under Article - 235 of the Constitution of India, the High Court of Madhya Pradesh, hereby posts **Smt. Neetu Kanta Verma**, I District & Additional Sessions Judge, **Shajapur**, in the capacity of **In-charge Principal District Judge, Shajapur** w.e.f. 01.07.2022. This assignment shall be in addition to her own duties till joining of regular Principal District & Sessions Judge at **Shajapur**.
