High Court has noticed a trend that the officers, who are in consideration zone for their posting on promotion, opt to forgo their posting on such post, so as to avoid posting at remote or small district place. Resultantly, the next junior judge is required to be posted on such posts.

Therefore, it has been decided that in case any judge is due for consideration for being posted on promotion, represents to forgo his/her posting on promotion, his/her name shall not be considered for a period of one year and such officer shall also be liable to be transferred (horizontal transfer) in the same capacity to any other place as per administrative exigency.
