In exercise of the powers conferred under Article 235 of the Constitution of India and other enabling provisions; the High Court of Madhya Pradesh, hereby, permits **Shri Dharminder Singh**, a Permanent Officer of Higher Judicial Service cadre, presently posted as Member Secretary, M.P. State Legal Services Authority, Jabalpur on his request letter, dated 17.09.2021 **to join the post of Member (Judicial) in National Company Law Tribunal (NCLT) on or before 25.10.2021;** in pursuance of his appointment for the said post; made vide Order No.A-12023/03/2019-Ad.IV, dated 11<sup>th</sup> September, 2021 and subsequent Order, dated 20<sup>th</sup> September, 2021 of the Under Secretary to the Government of India, Ministry of Corporate Affairs, New Delhi.

Sir,

With reference to your application for the above mentioned post, I am directed to state that the Central Government has approved your appointment for the post of Member (Judicial) in National Company Law Tribunal (NCLT) in the pay scale Rs. 67,000-79,000 (pre-revised) (Level 15 as per 7<sup>th</sup> CPC) for a period of five years from the date of assumption of the charge of the post or till you attain the age of 65 years or until further orders, whichever is earlier.

2. Your terms and conditions as Member (Judicial), NCLT will be governed by the NCLT (Salary and Allowances and other Terms and Conditions of Service of the President and Other Members) Rules, 2015 and its amendment (copies enclosed).

3. The pay of a serving or retired government officer or Chairman, Vicechairman, President, Vice-president, Presiding officer, Member of a Tribunal, Appellate Tribunal or an authority, or a judge of a High Court, who is or has been drawing higher pay, on their joining as Member, National Company Law Tribunal shall be fixed at the level of pay which they were drawing at the time of demitting their previous employment, subject to a limit of Rs 80,000 (pre-revised, now Rs 2,25,000). However, this provision shall not affect any other entitlement corresponding to the pay of a Member as provided in the rules.

4. In terms of proviso to section 413 (2) of Chapter XXVII of the Companies Act, 2013, the Member may retain his lien with his parent cadre or Ministry or Department, as the case may be, while holding office as such for a period not exceeding, one year.

5. You are requested to report to President, NCLT within two weeks from the date of issue of this letter, at 6<sup>th</sup> Floor, Block No. 3, Lodhi Road, CGO Complex, New Delhi – 110003. The place of your posting will be notified by the Ministry of Corporate Affairs in consultation with President, NCLT separately.
