In exercise of the powers conferred by sub-section (2) of Section 11 of the Code of Criminal Procedure 1973 (Act No. 2 of 1974) and in supersession of its Notification No. C/1816/III-6-4/57-40 dated 10th April 2016, the High Court of Madhya Pradesh appoints Shri Rohit Katare, Additional Chief Judicial Magistrate, Jabalpur to be the Presiding Officer of the Court of Judicial Magistrate First Class (Specially for C.B.I. Cases) established by the Government of Madhya Pradesh vide Law & Legislative Affairs Department Notification No. F-1/5/96/21-B(1), dated 03rd March, 2011 for the areas comprising the Districts Jabalpur, Katni, Balaghat, Betul, Chhindwara, Tikamgarh, Damoh, Hoshangabad, Harda, Chhatarpur, Narsinghpur, Rewa, Seoni, Mandla, Shahdol, Sidhi, Sagar, Satna, Panna, Dindori, Umaria, Anuppur and Singrauli for trial of offences investigated by the Special Police Establishment Act, 1946, except those specified in Chapter-III of Prevention of Corruption Act, 1988 (49 of 1988).
