## **AMENDMENTS**

In the said rule -

- 1. after Rule 8, the following rule shall be added, namely;
  - "8A. Duration of validity of the select list: In case of appointment under rule 5(1)(C), the select list of the successful candidates in the examination in any recruitment year shall be valid upto 12 months from the date of declaration of the select list.
- 2. in rule 14, Sub Rule (1) shall be renumbered as clause (a) of sub-rule (1) and after so renumbered clause (a), the following clause shall be added, namely:-
  - "(b) Without prejudice to the provisions contained in sub-rule (2), a member of the service not found fit and suitable shall be compulsorily retired on his attaining the age of 58 years."
