
Shri Anand Jambhulkar, Judicial Magistrates First Class, Jabalpur is hereby appointed as Presiding Officer of the Court of Special Magistrate, established by the Government of Madhya Pradesh for the trial of offences of Railway Property (Unlawful Possession) Act, 1966 (No. 29 of 1966) and under Section 137 to 147, 150 to 157, 159 to 168 and 172 to 176 of the Indian Railways Act, 1989 (Act No. 24 of 1989) and for all other penal provisions of this Act in which Judicial Magistrate First Class is empowered to take cognizance, arising within the Railway Lands running through the territories of Revenue Districts shown in the following table with effect from the date of his assumption of charge of the office. The headquarter of the Court shall be at Jabalpur.

This notification is being issued in supersession of earlier notices issued in respect of Jabalpur.
