दण्ड प्रक्रिया संहिता 1973 (अधिनियम क्रमांक 2 सन् 1974) की धारा 11 की उपधारा (2) द्वारा प्रदत्त शक्तियों को प्रयोग में लाते हुए उच्च न्यायालय मध्यप्रदेश निम्न तालिका के स्तम्भ 2 में उल्लेखित न्यायिक मजिस्ट्रेट को मध्यप्रदेश शासन, विधि और विधायी कार्य विभाग, भोपाल द्वारा खाद्य अपमिश्रण निवारण अधिनियम 1954 (क्रमांक 37 सन् 1954) तथा मध्यप्रदेश म्यूनिसिपल कॉर्पोरेशन एक्ट 1956 (क्रमांक 23 सन् 1956) द्वारा या उनके अधीन घोषित अपराधों से संबंधित मामलों के विचारण के लिए स्थापित न्यायिक मजिस्ट्रेट प्रथम श्रेणी के न्यायालय को विशेष मजिस्ट्रेट के रूप में नियुक्त करता है। उक्त न्यायालय का मुख्यालय तालिका के स्तम्भ 3 में वर्णित स्थान पर होगा।
