In exercise of the powers conferred by Sub-Section 3 of Section 9 of Code of Criminal Procedure, 1973 (Act no. 2 of 1974) and all other enabling provisions, the High Court of Madhya Pradesh, hereby designates the Courts of the Additional Sessions Judges mentioned in column no. (3) of the following table at the places mentioned in column no. (2) for trial of cases in respect of offences relating to **VYAPAM** Scam matters and matters linked thereto, investigated by the Central Bureau of Investigation, by Special Task Force or by Local Police Stations.


