This appeal coming on for final hearing this day, the court passed the following:

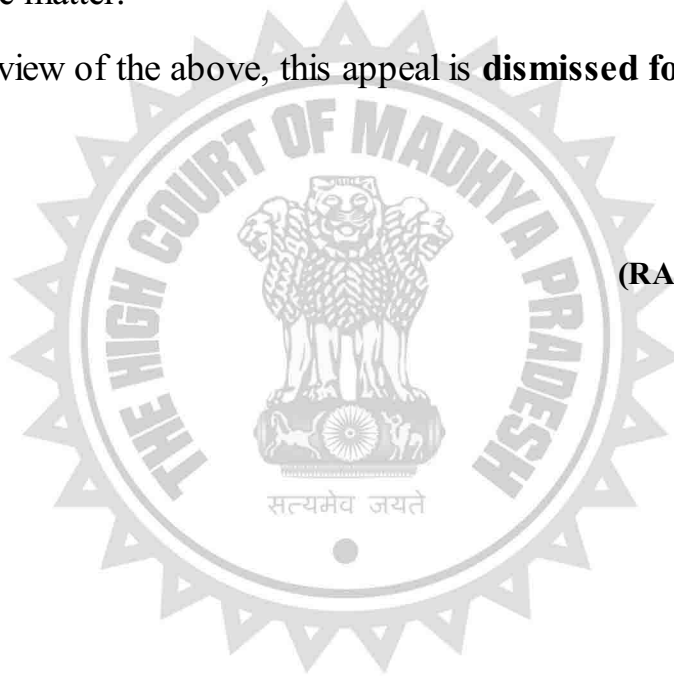
ORDER
